**Commercial Exhibitors and Concession Stands**

**The following are for your information and rules:**

- **ABSOLUTELY NO** Styrofoam cups can be used. If you are using styrofoam you will be told to remove your booth from the fairgrounds.
- All exhibitors Everyone will be required to stay in the place that they are assigned.
- The Fair board should be informed of any special electricity requirements at least two weeks prior to the fair. A maximum of 50 amps per vendor will be allowed.
- No concession exhibitors will be allowed to be located next to the 4-H food stand.
- No loudspeakers, megaphones or intercom systems of any kind will be allowed on the fairgrounds.
- No signs advertising products will be allowed around the fairgrounds except in front of the location that is assigned to your exhibit or concession.
- The commercial building will be open at 5:00 p.m and locked at 9:00 p.m. Monday through Saturday evenings. Some commercial exhibitors may be located in the 4-H exhibit building.
- All concession stands will be located outside of the buildings.
- Spaces will be reserved ONLY when fees are paid.
- ALL EXHIBITORS MUST PROVIDE PROOF OF INSURANCE OF LIABILITY FOR THE FULL WEEK OF THE FAIR. Please send this along with your booth rental fee. Check with your insurance provider most are covered under your homeowner's policies.
- Booth space is as follows:
  - Non-food space (inside) – \$75.00
  - Non-food space (outside) - \$125.00
  - One specialty food item - \$200.00
  - West end of Grandstands - \$400.00
  - Several food items (East of Grandstands) - \$400.00

PLEASE NOTE: WE ARE ALSO INCLUDING 2 SEASON PASSES WITH THE ABOVE RENTALS, WHICH ARE AT A REDUCED COST TO EXHIBITOR. Several of you have asked for this change so that the cost can be made as a Tax-deduction.
